NOTICE TO MOBILE HOME OWNERS:

Mobile homes not part of a trailer park or trailer court damaged during the 2016 flood may be replaced and inhabited by the person(s) residing in the mobile home prior to the flood (hereinafter referred to as the "original occupant") upon obtaining a permit from the City of Denham Springs. "Original occupant" is defined as the adult owner who occupied the home at the time immediately prior to the 2016 flood as named on the deed as it existed immediately prior to the 2016 flood. Minor children occupying the home are not considered to be "original occupants" for the purpose of the time periods set forth in this provision.

UNDER NO CIRCUMSTANCES SHALL ANYONE OTHER THAN THE ORIGINAL OCCUPANT(S) AND THEIR MINOR CHILDREN BE ALLOWED TO RESIDE WITHIN THE MOBILE HOME. FAILURE TO COMPLY WITH THESE REQUIREMENTS WILL INVALIDATE ANY PERMIT ISSUED BY THE CITY OF DENHAM SPRINGS AND WILL RESULT IN THE REQUIREMENT THAT THE MOBILE HOME BE REMOVED FROM THE CITY LIMITS.
